**An Ordinance Amending Title 2 Boards and Commissions,
Chapter 19 Water, Electric and Communications Board of Trustees,
Section 5 Trustee Requirements**

BE IT ORDAINED by the City Council of the City of Muscatine, Iowa, as follows:

Section 1. Title 2, Boards and Commissions, Chapter 19 Water, Electric and Communications Board of Trustees, Section 5 Trustee Requirements is hereby amended to read as follows:

2-19-5 Trustee Requirements. Each member of the Board of Water, Electric and Communications Trustees shall be a resident of the City of Muscatine or reside in a water or electric service territory of the City of Muscatine. A public officer or a salaried employee of the City may not serve on the Utility Board.

Section 2. All ordinances or portions of ordinances in conflict herewith are hereby repealed.

Section 3. This Ordinance shall become effective upon passing and publication as provided by law.

AN ORDINANCE AMENDING TITLE 2 BOARDS AND COMMISSIONS, CHAPTER 19, BOARD OF WATER, ELECTRIC AND COMMUNICATIONS TRUSTEES: SECTION 5.

Be it enacted by the City Council of the City of Muscatine, Iowa:

SECTION 1. AMENDMENT. TITLE 2 BOARDS AND COMMISSIONS, CHAPTER 19, BOARD OF WATER, ELECTRIC AND COMMUNICATIONS TRUSTEES: SECTION 5 of the City Code of Muscatine is hereby amended as follows:

2-19-5 Trustee Requirements. Each member of the Board of Water, Electric and Communications Trustees shall be a resident ~~of the City of Muscatine, Iowa.~~ of Muscatine County who is a customer of any utility service provided by the Board of Water, Electric and Communications Trustees of the City of Muscatine, Iowa. A public officer or a salaried employee of the City may not serve on the Utility Board.

SECTION 2. REPEALER. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

SECTION 3. SEVERABILITY CLAUSE. If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

SECTION 4. WHEN EFFECTIVE. This ordinance shall be in effect from and after its final passage, approval and publication as provided by law.
