INTRODUCTION:

The Hershey Ave. Reconstruction Project is in the final stages of design and approval from the IDOT. It is necessary to set a date for the Public Hearing regarding this project.

BACKGROUND:

The Hershey Ave. Reconstruction Project has been designed and carries a cost estimate of \$1,400,000 with \$381,415 funded via the Surface Transportation Program. This project is expected to be let in March 2011 by the Iowa Department of Transportation and construction to begin in the Spring of 2011 with completion by the Fall of 2011.

RECOMMENDATION/RATIONALE:

It is necessary for the City of Muscatine to hold a Public Hearing on this Capital Project. We request the Hearing to be at the January 20, 2011 city council meeting.
