SUBJECT: City Council Agenda Item – Issue Purchase Order for Professional Services for Civil Engineering for Station #2 Project

INTRODUCTION:

Requesting to issue purchase order to Martin & Whitacre Surveyors & Engineers, Inc. for professional services of civil engineering for the Station #2 project.

BACKGROUND:

The City of Muscatine has been working on the new Southend Fire Station project for the last year and we are towards the final phases before breaking ground in March of 2011. Prior to the construction documents going out to bid we need to perform civil engineering on the proposed site. Martin & Whitacre has previously been involved in the project and is currently working on the required ALTA Survey and City staff is proposing that they do the civil engineering on the site also. Their proposal would include the topographic survey, preliminary engineering work, and construction plans at a total cost of \$ 9,000. If requested, additional services such as general construction staking, field engineering, and attending construction meetings would cost an additional \$ 4,000.

RECOMMENDATION/RATIONALE:

The Muscatine Fire Department is requesting that City Council issue a purchase order to Martin & Whitacre for professional services for civil engineering for the new Southend Fire Station site for \$ 9,000, but not to exceed a total cost of \$ 13,000 for additional services for the project.

Phase 3: Construction Plans: \$2,000

Includes preparation of civil engineering construction plans to address paving, grading and utility layout.
