SUBJECT: Station # 2 Public Hearing

INTRODUCTION:

A public hearing is required for this new South End Fire Station Project. The public hearing is proposed for the February 3rd, 2011 City Council meeting in anticipation of a March 3rd, 2011 bid award date.

BACKGROUND:

The Muscatine Fire Department has been involved in a new Southend Fire Station project since May of 2009 and plan on breaking ground in March of 2011.

The construction cost estimate for this project is \$1,300,500.00 for a 9,850 square foot fire station with \$850,250.00 from the I JOBS II Grant, \$ 200,000.00 from the Iowa Department of Economic Development Grant, and the city's share of the project is \$ 250,250.00 from the General Obligation Construction Bond.

It is anticipated to begin construction towards the end of March 2011, with an estimated completion date of March 2012.

RECOMMENDATION/RATIONALE:

Recommend the City Council hold public hearing on February 3rd, 2011 to discuss project.

WHEREAS, the City Council of the City of Muscatine, Iowa has heretofore granted preliminary approval of the plans, specifications, form of contract, cost estimate, and setting bid opening date for the proposed South End Fire Station Project;
