## TIF REBATES, URBAN RENEWAL ON COUNCIL AGENDA

Council asked to approve appropriation of rebates, and internal advance of funds

**MUSCATINE, Iowa** – The approval of 15 appropriations for FY2024-2025 Tax Increment Financing (TIF) rebates and the approval of four advances of funds for Tax Increment Urban Renewal Projects are among the items on the Muscatine City Council agenda for Thursday (Nov. 16).

The Council meeting begins at 6 p.m. and the public is welcomed and encouraged to attend the session in person.

TIF is used by public bodies as a subsidy, or joint investment, in the development or redevelopment of an area including infrastructure and other community-improvement projects.

This may include upgrading areas of the city suffering from slum and blight, helping residential development efforts, and enhancing economic development activities. Depending on the size of the project, cities may need to incur debt to finance an improvement, such as installing infrastructure. The city would then use the incremental property tax revenue to make their debt payments. Approving the internal advance of funds is a way to create the debt needed for the TIF projects. - Acceptance of the Lead Hazard Reduction and Healthy Homes Grant.
