From the City Administrator

Could it be that spring is around the corner in Muscatine? I was walking to a meeting the other day and looking up I saw that a tree along the sidewalk had buds! A hopeful sign that warmer weather is around the corner and we will all soon be enjoying our parks and recreation facilities as well as our community trails and other amenities.



As you get out of the house to enjoy the spring weather, you may want to take your dog along for a walk or for a trip to the Muscatine Dog Park. I am a frequent visitor to the Dog Park with my two dogs, Cosmo and Hazel. I recently renewed my City pet registration, so don't forget to also do so if your pet is unregistered or the registration has lapsed. Currently a one year registration is available for free for currently unregistered, neutered pets until April 30. Registration is available at City Hall of Muscatine, 215 Sycamore Street, or you can register at two upcoming community pet events. It Takes a Village Animal Rescue and Resources, along with national nonprofit Petco Love, will host



the first of a series of "Promoting Responsible Pet Ownership" events from 1-5 p.m., Saturday (March 19), at the Salvation Army, 1000 Oregon St., Muscatine. The Muscatine Humane Society, 920 S. Houser Street, Muscatine, will be hosting a low-cost event for dogs and cats from 3-6 p.m. on Friday, April 8, that will include rabies vaccination and microchipping on a first come, first served basis.

It is great that we have local organizations and community members willing to promote responsible animal ownership in Muscatine. My dog Hazel

was adopted from the Muscatine Humane Society (a great organization!) and is a fun loving pet who loves to chase big dogs at the Muscatine Dog Park and taking rides on the paddleboard! As City staff begin implementing recently adopted pet regulations in Muscatine, keep in mind that the City regulates pet ownership for the health and safety of both pets and humans in our community. Taking responsibility for your pet means a safer and healthier community for everyone.

As I mentioned in last month's report, the City of Muscatine conducted a community survey to provide Muscatine residents with an opportunity to rate the quality of life in Muscatine and your satisfaction with community amenities and their local government. The survey results will be compared to national benchmarks and will help guide the City Council in setting goals for future years. The survey closed March 11 and the City staff plans to review the results of the Survey with the City Council in May. We had over 700 community members complete the survey, which will give us some good data on moving Muscatine forward.

Finally, please tune in for the Mayor's State of the City Address. The Address will be part of the March 31 Muscatine In Focus show where the Mayor and I will answer questions submitted by the community. Highlights of City Activity

- **Department of Administration** - Presented 27 regular agenda items for consideration by City Council. Provided presentations to City Council on vacant property and non-residential property maintenance, placement of cargo containers in residential areas, weeds and vegetation management, and development of Carver Corner.
- **Department of Public Works** – The Collection & Drainage Division is responsible for inspecting and maintaining the city's sanitary, storm, and combined sewer systems. This includes 993 storm water manholes, 2,407 sanitary sewer manholes, 151 combined sewer manholes, 2,840 stormwater catch basins, 112 miles of sanitary sewer and 68 miles of storm sewer pipe. For the month of February the Collection & Drainage Division continued their inspection of our off-road sewer lines. 31,170 feet of sewer lines were walked to look for holes or leaks. All manholes were opened and were visually inspected.
- **Finance Department** – Prepared materials for the rest of the department budget review sessions; attended all budget review meetings. Prepared the Amended Budget and FY23 Budget on the Department of Management Website and prepared the notices for public hearings. Worked with the City's bond attorney and financial consultant on the documents needed for the pre-levy of taxes for the May 2022 bond issue.
- **Community Development Department** – We are looking for customer feedback on services provided by Community Development, to that end a customer survey is now available at <https://www.surveymonkey.com/r/FPXBZ8T>
- **Housing Agency** – A soon to be Muscatine High School graduate was awarded a college scholarship through the Iowa Chapter of the National Association of Housing & Redevelopment Officials. Her application will now be considered for another scholarship by the Regional Chapter of the organization.
- **Parks and Recreation Department** – Youth and adult recreation programs and special events continue to be offered while adhering to COVID-19 safety protocols. Current programs taking place include Gymnastics, Adult Volleyball Leagues, BlastBall and the Walking Club. The 2022 Easter Egg Hunt is scheduled for Saturday, April 9 at 10:00 a.m. in Weed Park.
- **Fire Department** – Hosted an informational night for an Explorer Program. This program is open to youths age 14-21 who are interested in learning more about a career in fire and emergency medical services. The program will be held on the 1st and 3rd Sunday of every month. This program is tied into our overall recruitment plan.
- **Police Department** – Officer Mitchell Griffin was asked to provide a K-9 demonstration by a Calvary Church youth group (age of children attending ranged from 5-15 years of age). The goal of the interaction was to create a positive image of law enforcement for the children in attendance. The presentation was well received and Officer Griffin has been invited to be a part of future/ similar events through the church. Officer Griffin is commended for his participation in an activity designed to enhance the department's standing within the community.

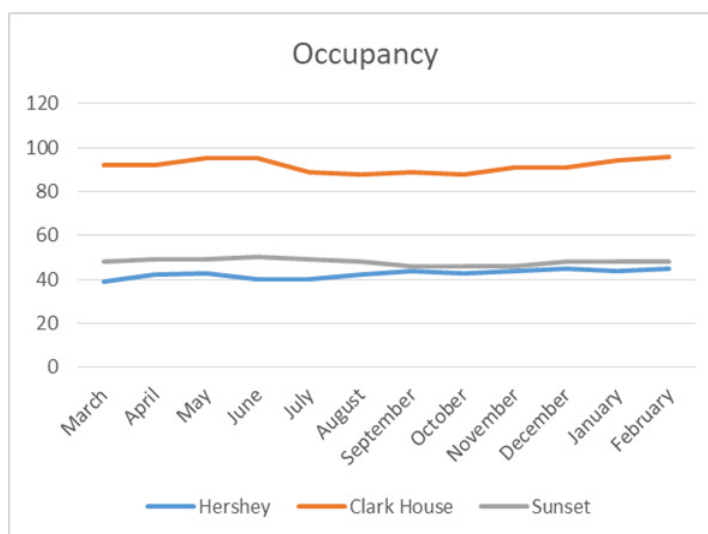
Muscatine Municipal Housing Agency

- There are currently 37 families participating in the Family Self-Sufficiency Program.
- Housing Choice Voucher (Section 8) staff conducted 2 briefings. 69 individuals were invited, and 17 vouchers have been issued.



- Paid \$139,926 to private landlords and utilities on behalf of assisted clients
- \$6,052 was deposited into escrow accounts for families working toward self-sufficiency
- Received \$18,388 in administrative fees based on the 84% proration of fees earned



- Completed 125 work orders. The average repair time went down ½ a day from January to February, from 1.9 days to 1.4.
- 3 households moved into Clark House and Hershey Manor.

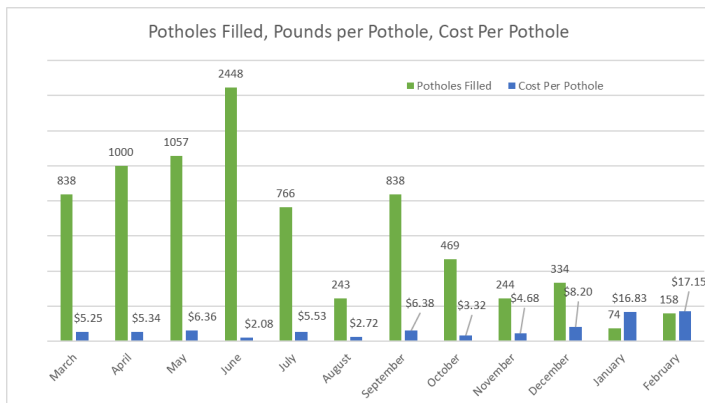

Department of Public Works

The Public Works Department is composed of eight divisions which include: Administration, Building & Grounds Maintenance, Collection & Drainage, Engineering, Roadway Maintenance, Solid Waste, Transit (Muscabus), and Vehicle Maintenance. For budgeting purposes several of these divisions are broken down into subdivisions. For the purpose of the monthly report there will be several divisions that will be reporting consistently, while others may only be reporting on special events or accomplishments.

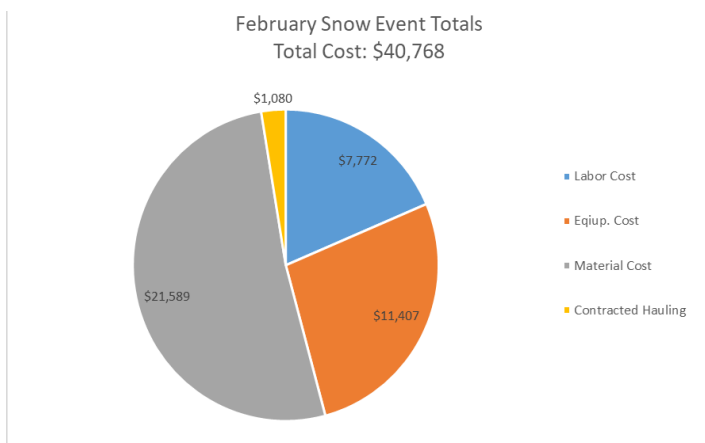
Roadway Maintenance Division Report:

Roadway Maintenance includes activities related to street repairs, snow removal, traffic control, and street cleaning. They are responsible for over 254 lane miles of streets within the city limits.



This measure indicates the number of potholes filled, and the approximate cost to fill each pothole. Beginning January 20, 2021, a "standard" pothole is defined as being the size of large pizza box. Potholes will be divided no smaller than one half of a pizza box.

Building and Grounds Activities:

This month in addition to their regular duties including cleaning, plumbing, electrical, HVAC work, supply ordering and delivery, and other regular repairs, staff have been completing multiple projects including: installed a new electrical box, conduit, wire and breaker and repaired the treadmill at the South Fire Station; replaced the hanging furnace in the brine building at the former DOT property; replaced ceiling tiles in the engineering department, hallway and restrooms at the Public Works Building, also painted an office and replaced a faucet at Public Works.

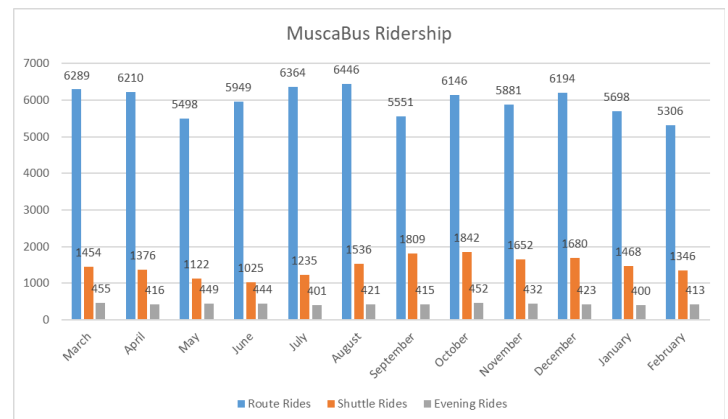
In addition, staff performed snow removal at city buildings and bus stops, tested three back flow preventers in various buildings for multiple departments, and cut keys for the golf course and other departments.

The former Kum & Go Building finished installation of new garage doors, weather stripping and door operators.

Staff continue to utilize the PubWorks asset management software and are now using it to create preventive maintenance work orders, standard operating procedures, and lock out-tag out procedures.

Transit Summary of Operations:

MuscaBus is the city's transit service. It operates four fixed routes, shuttle service, and evening service.

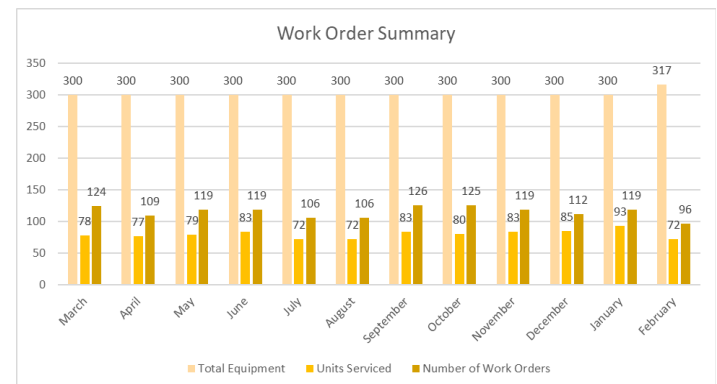

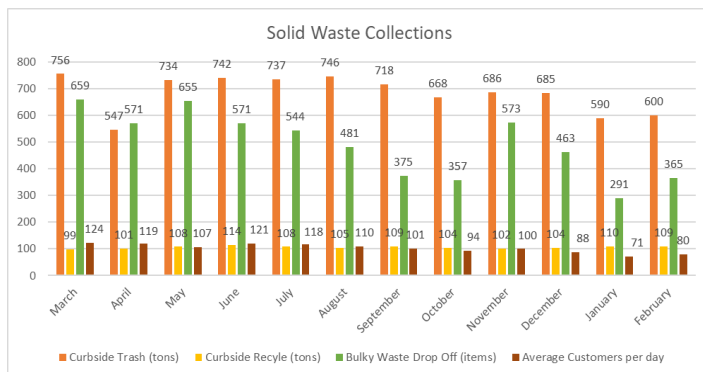
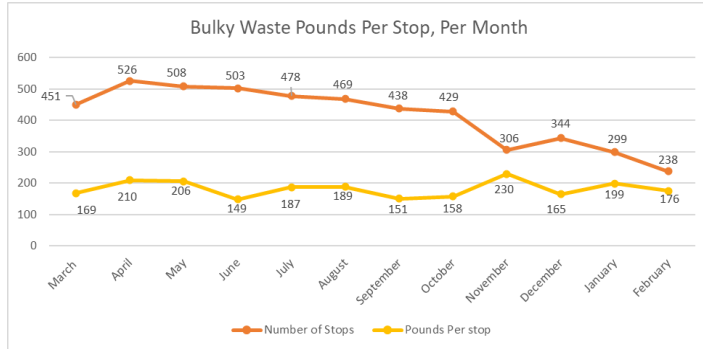

The Solid Waste Division consists of activities related to refuse collection, transfer station, compost site, and landfill, as well as overseeing the contracted recycling collection.

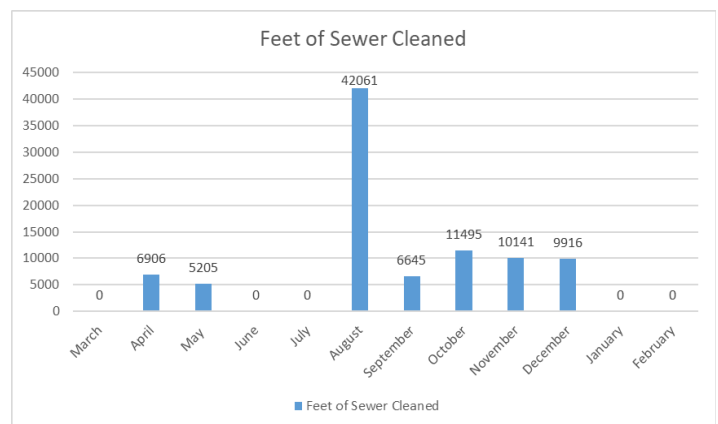
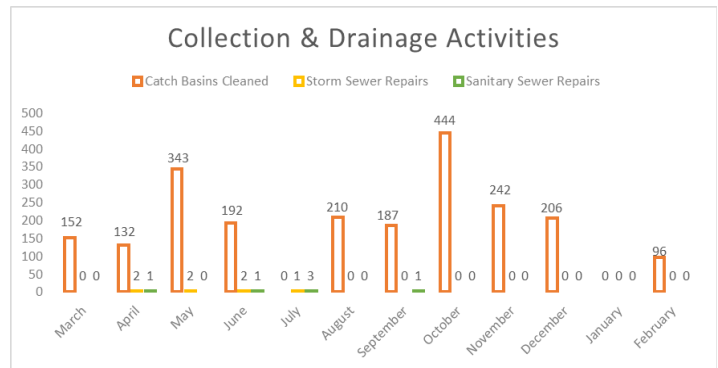

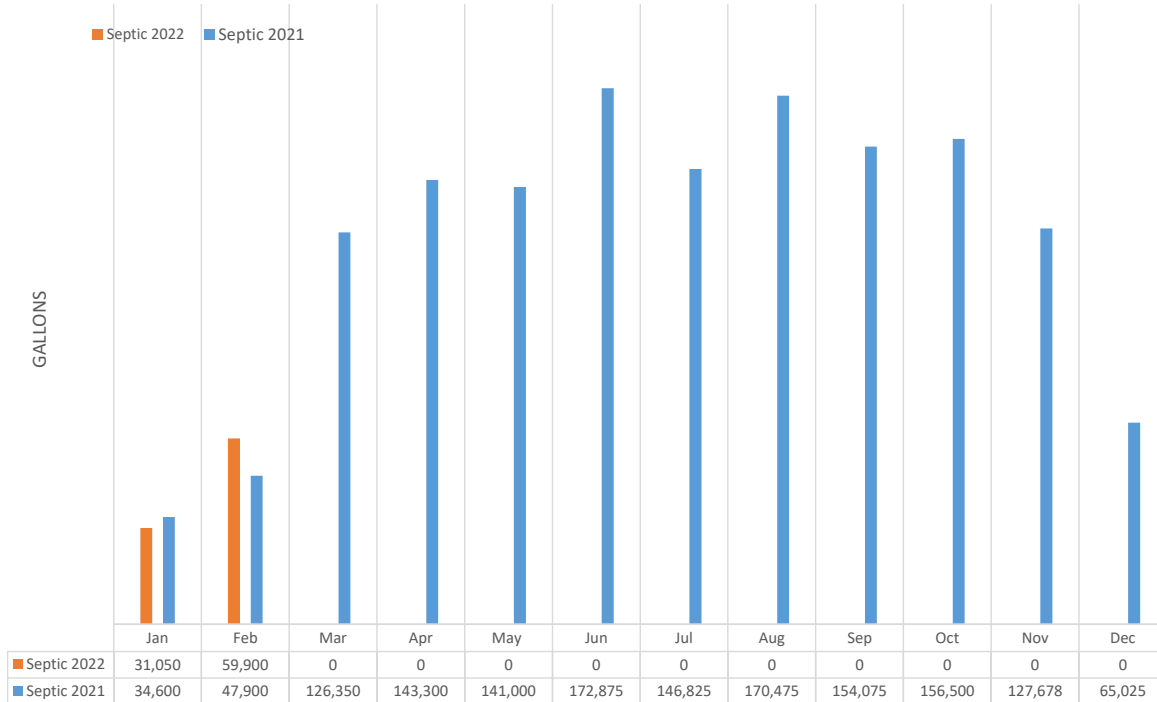

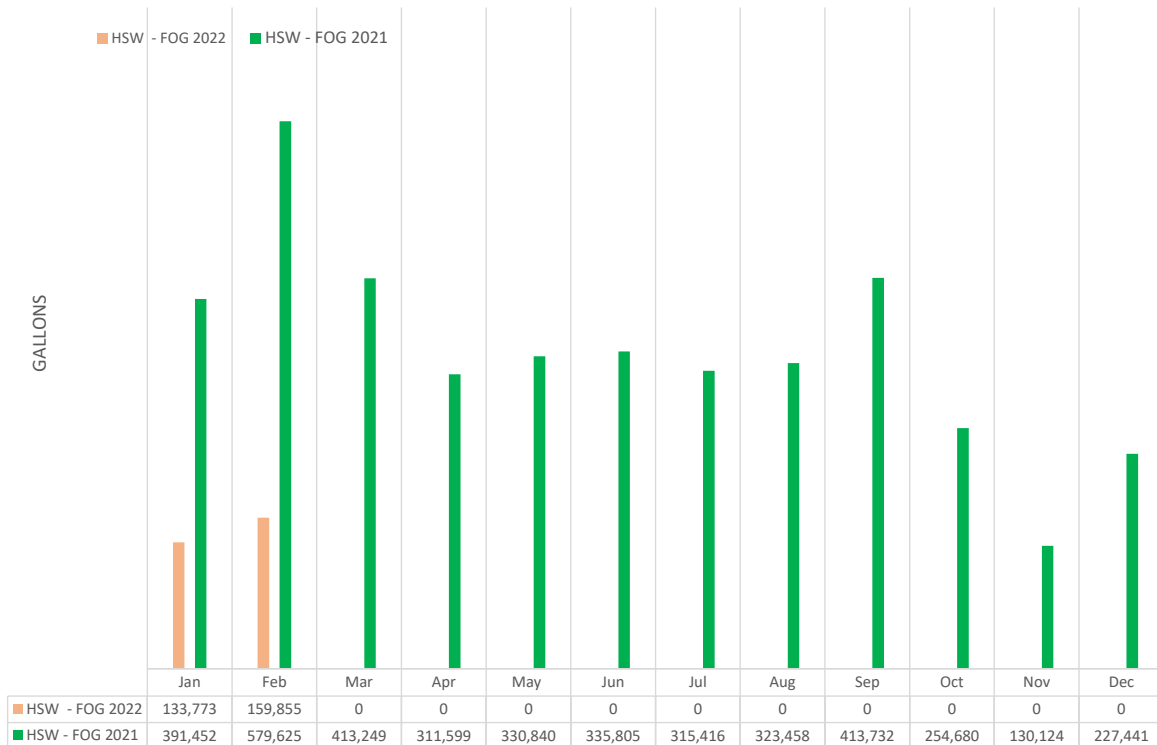

MUSCATINE WRRF HAULED SEPTAGE WASTE 2022

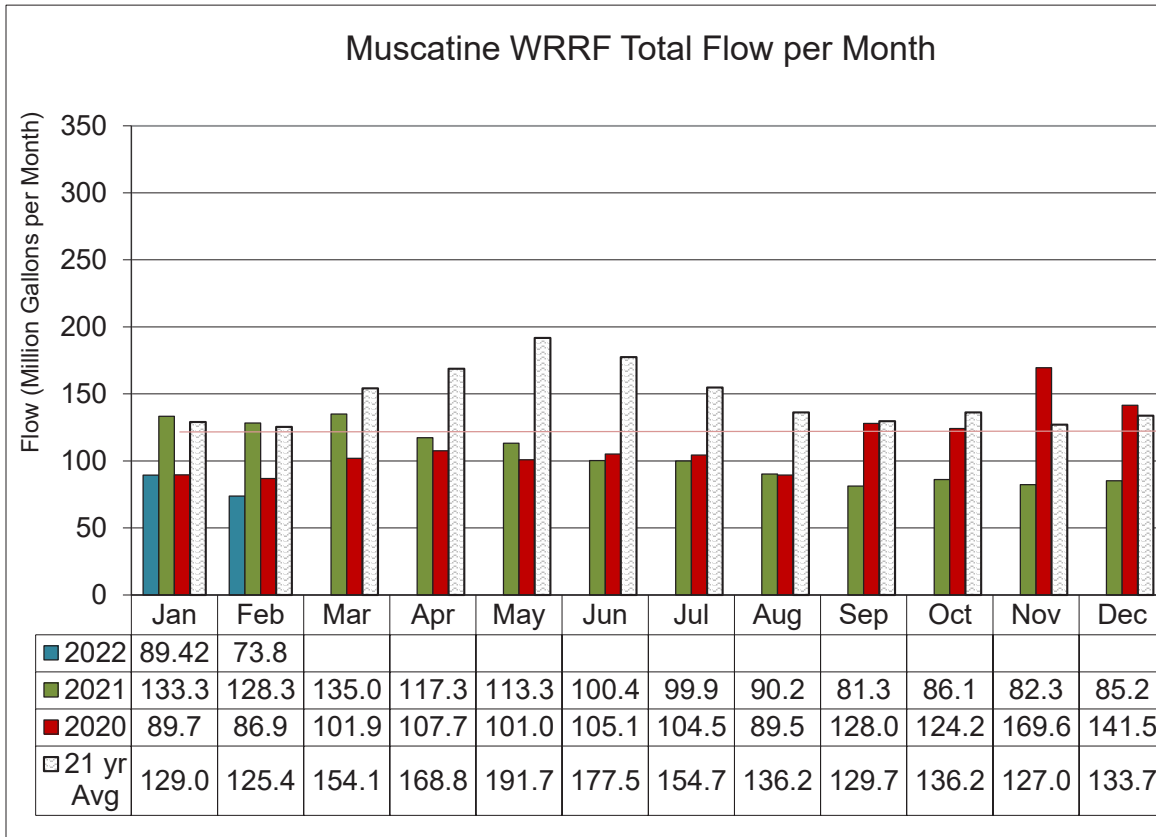
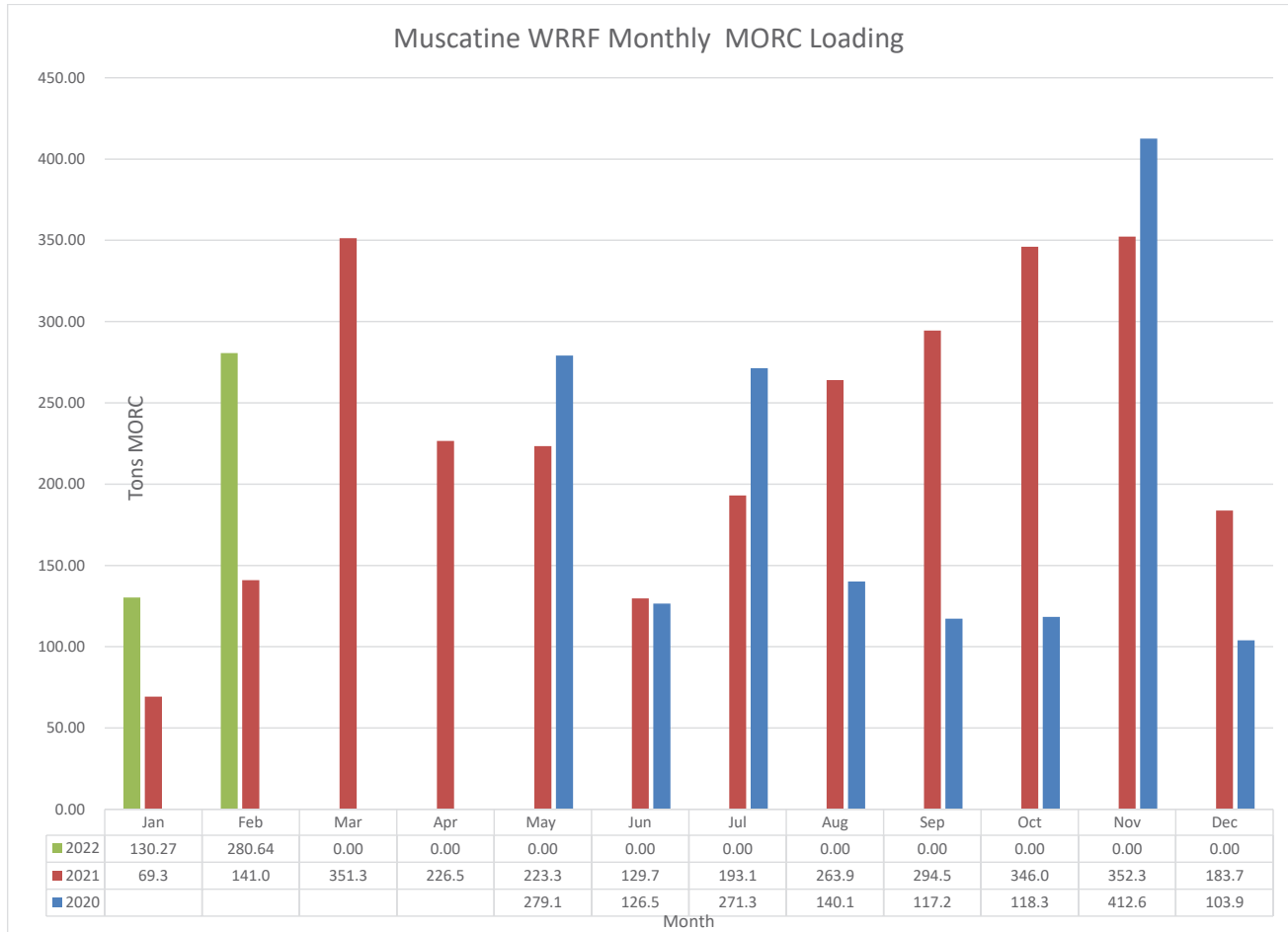


MUSCATINE WRRF HAULED FOG - HIGH STRENGTH WASTE 2022

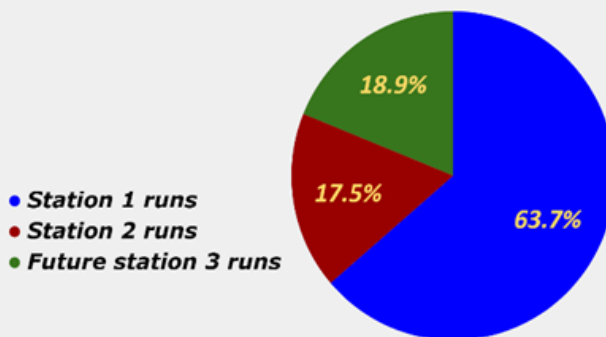
Staff Updates

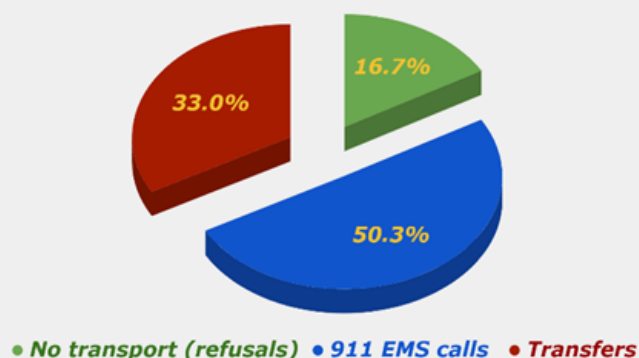
Compliments to firefighter Ben Barrett for implementing the fire department Explorer Program.

Muscatine Police Department

February Highlights

- The PD hosted our monthly Coffee with a Cop.
- Animal Control Officer Courtney Patel handled two different calls involving dog rescues in February. One of the calls she handled had 42 dogs she rescued in Fruitland from a residence that was not habitable for animals. The other was in town that had dogs that had to be removed due to the conditions of the residence and not being taken care of by the owner.
- Detective Adam Raisbeck was in continuous contact with an informant about the location of an over the road truck driver who had three active arrest warrants for Sex Abuse, Lascivious Acts, and False Imprisonment. Detective Raisbeck learned that the wanted subject was coming to Muscatine, so he waited for him to arrive and arrested him with the assistance of Detective Jeff DeVrieze, Detective Casey Jensen, and Detective Britt Jameson. Detective Raisbeck executed a search warrant on the man's semi-truck and located more evidence to add to the case.
- In early February, Detective Joe Roseman was monitoring inmate phone calls from the Muscatine County Jail and learned of a video that depicted an inmate committing sex acts with a child. Detective Roseman was able to track down the video through a search warrant. Detective Roseman has presented the case to the FBI and they have accepted it for federal prosecution.
- Detective Jeff DeVrieze helped the Animal Control Officer (Courtney Patel) on an Animal Neglect case. Detective DeVrieze was granted a search warrant, for a trailer in Fruitland, to allow Courtney to remove 42 dogs from unsanitary living conditions. The dogs were all taken in by the Muscatine Humane Society. Detective DeVrieze issued 84 citations to the two dog owners and gave them options for alternate housing.
- Detective Adam Raisbeck assisted the Animal Control Officer (Courtney Patel) in helping an elderly woman turn her 2 dogs over to the Muscatine Humane Society. Detective Raisbeck helped the elderly woman get services through Community Services that included medical attention and new living accommodations.
- Officer Mitchell Griffin was asked to provide a K-9 demonstration by a Calvary Church youth group (age of children attending ranged from 5-15 years of age). The goal of the interaction was to create a positive image of law enforcement for the children in attendance. The presentation was well received and Officer Griffin has been invited to be a part of future/similar events through the church. Officer Griffin is commended for his participation in an activity designed to enhance the department's standing within the community.
- Captain Tony Kies and Lieutenant Ryan Buss presented Code Blue program to the Rotary Club.
- Department wide training conducted for Mental Health and Mandatory Reporter for Child Abuse and Dependent Adult Abuse

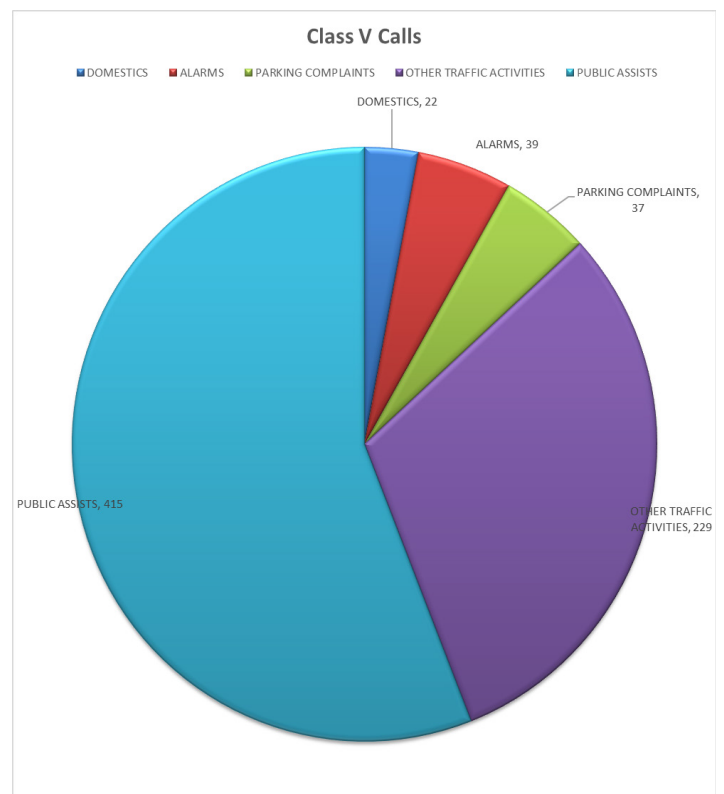
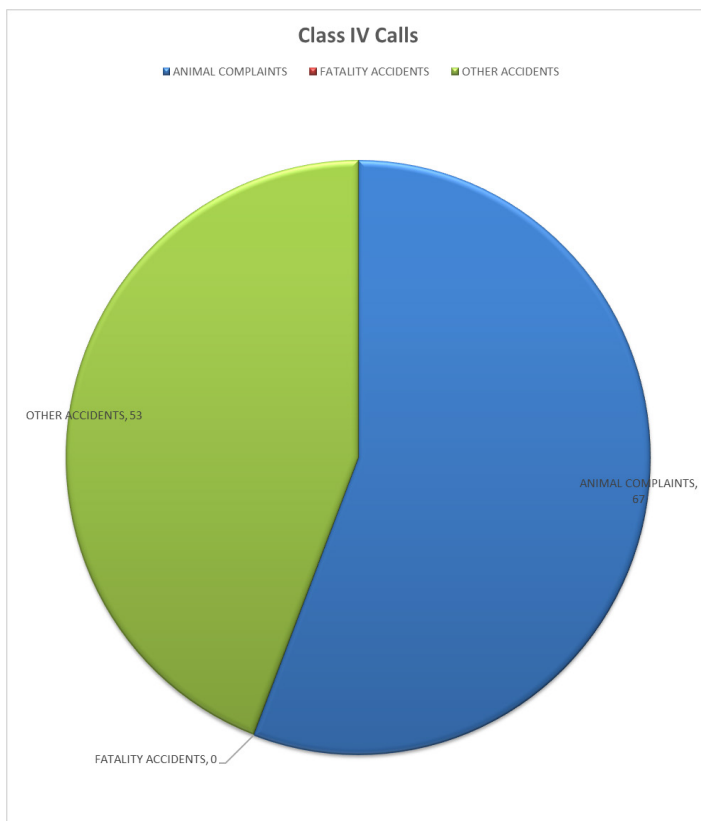
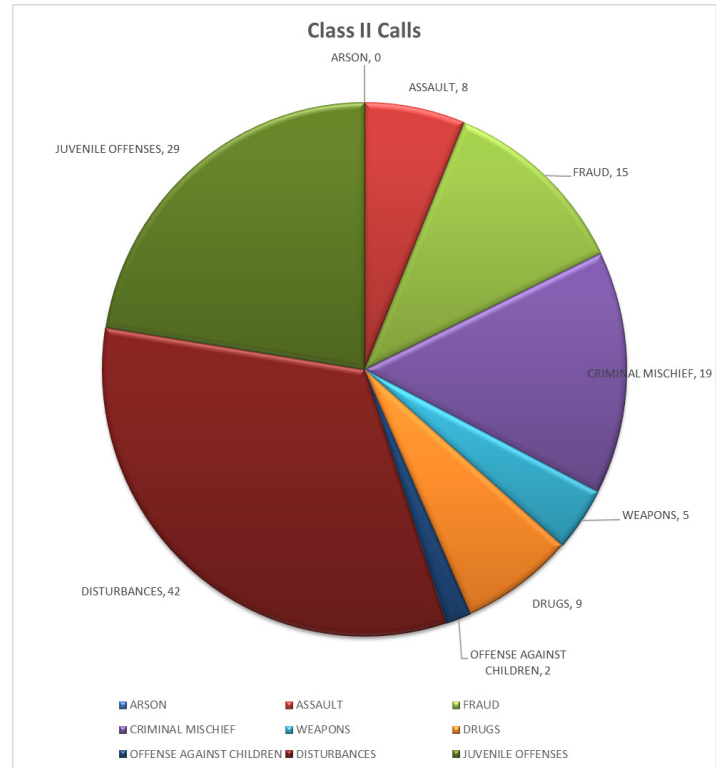
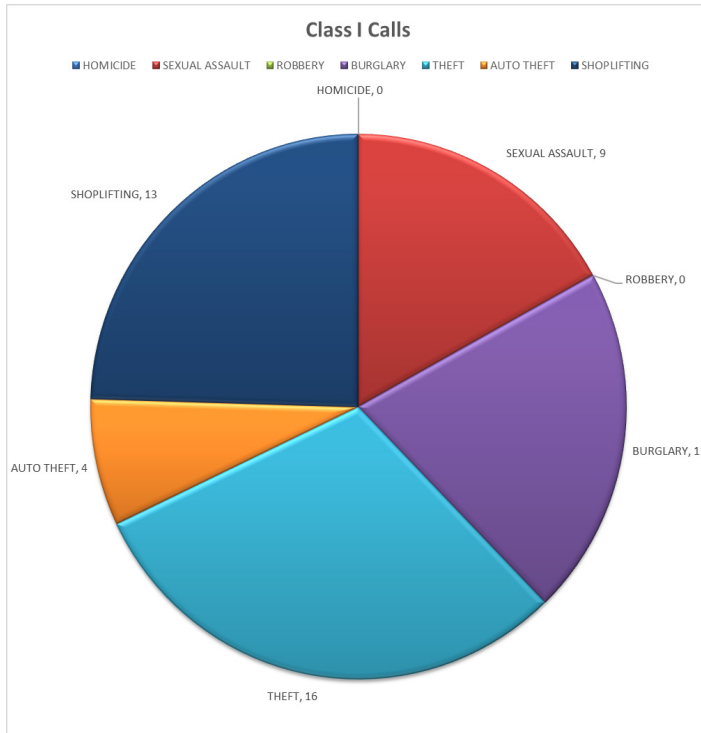
