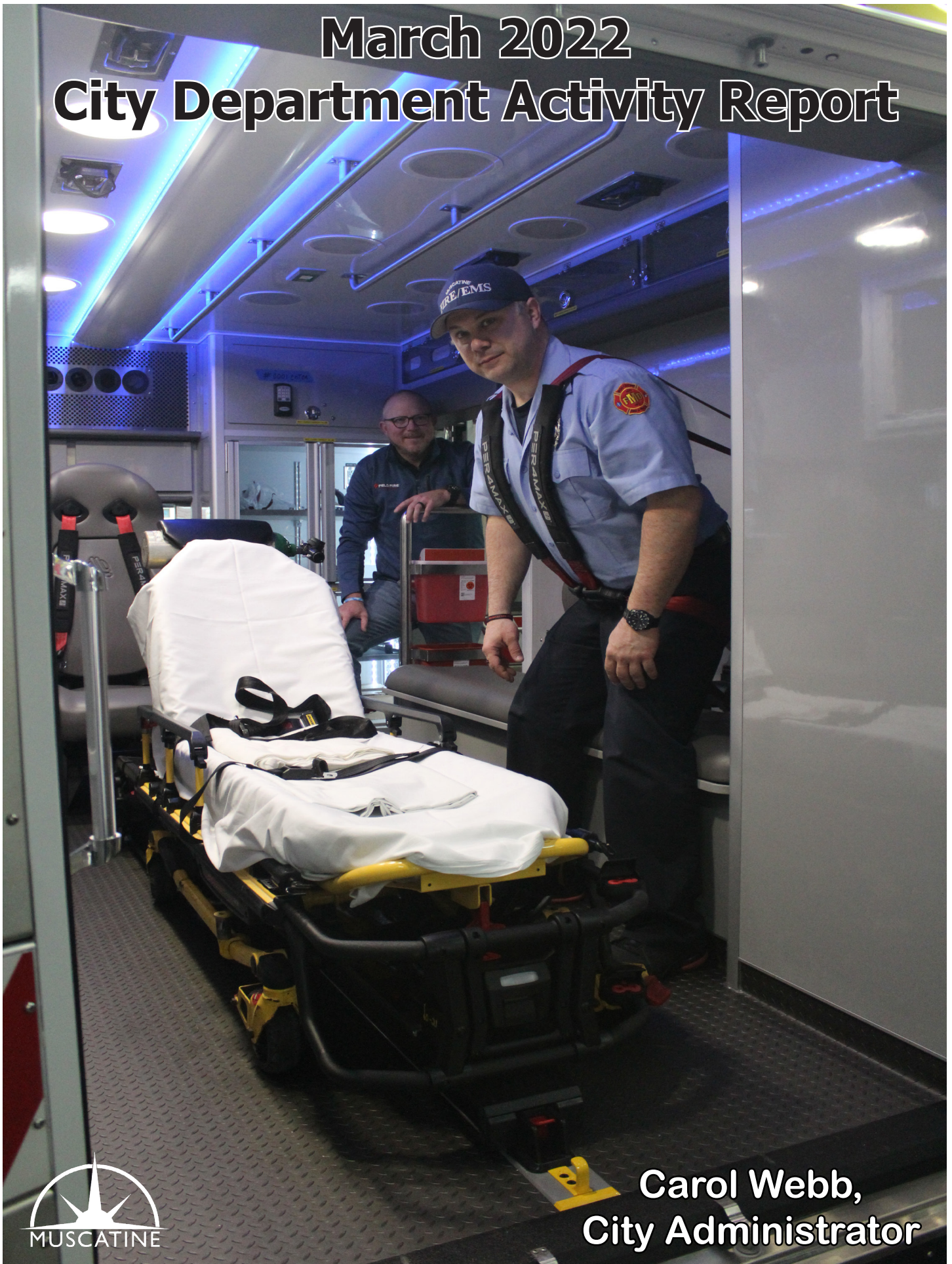

From the City Administrator

There are many exciting things happening in Muscatine! City Council's top community priorities, including housing, a thriving economy, and vibrant neighborhoods are moving forward with a variety of programs and initiatives.



One of City Council's top priorities is to support housing projects that increase the availability of quality housing for all. To that end, the City Council recently passed a resolution supporting a Workforce Housing Tax Credit Application for a housing project at Carver Corner (on the corner of Green Street and Hershey Avenue). The City Council is also in the process of adopting property maintenance codes, which establish maintenance standards for vacant properties that have been continuously vacant for one year or longer and non-residential properties both occupied and non-occupied. The objectives of this code are to prevent deteriorated and unsafe buildings in our community. We hope this code will be one of many tools the City uses to support and promote a vibrant community.

The City is also pursuing additional projects in

our downtown area. We recently had a team from the Iowa Downtown Resource Center perform an onsite study of our downtown to identify strengths, opportunities, and solutions. We will receive a report from the assessors with short and long-term recommendations specific to downtown Muscatine.

The Southend Community Improvement Projects are moving forward! You will see lots of activity in the coming months in Taylor, Musser, and Kent-Stein Parks. Improvements include a splash pad and pickleball courts (in Taylor Park), new picnic shelters, all-inclusive playground equipment, and new trail connections. The construction of the new features will occur over the summer months and potentially into next year. These are exciting new amenities that support vibrant neighborhoods!

Highlights of City Activity

- **Department of Administration** - Presented 33 regular agenda items for consideration by City Council. Provided presentations to City Council on McKee Building Development Project by Kent Corporation and an update to the Love's Project.
- **Department of Public Works** – Buildings & Maintenance staff have been completing multiple projects including: installed a new circulation pump, and restroom vent fan, painted an office and moved furniture in preparation for carpet replacement in City Hall; painted an office, replaced tile flooring, repaired a garage door, completed the lower lot gate project, and moved furniture and offices for preparation for carpet replacement at Public Works; replaced batteries and adjusted the automatic gate at the airport; repaired a backflow valve at the Transfer Station. In addition, staff performed fire extinguisher and furnace preventive maintenance inspections for multiple departments, and cut keys for other departments.
- **Finance Department** – Prepared the Amended Budget and FY23 Budget on the Department of Management website and prepared the notices for public hearings. Submitted the Amended Budget and FY23 Budget to State and County as required.
- **Community Development Department** – Implemented the rental report component of SmartGov in order to create inspection reports in a consistent manner. A new Coordinator for the Muscatine Heart & Soul project was hired to get the community engagement initiative restarted. - **Housing Agency** – An anonymous donor reached out to identify a client working toward self-sufficiency through education and has provided a \$250 stipend for the identified family. Two briefings were conducted for Voucher applicants, resulting in two more families enrolled in the Family Self-Sufficiency Program, for 39 total participants.
- **Parks and Recreation Department** – The City of Muscatine has been recognized as a Tree City USA community for its 30th consecutive year. In the spring of 2021, the Parks and Recreation Department partnered with HNI for a donation and planting of 500 trees throughout the community. With this partnership, the City nominated HNI for an award with the Iowa Urban Tree Council, and in March it was announced that HNI had received the Outstanding Local Partner Award!
- **Fire Department** – As part of our departments leadership training we participated in a department wide cultural survey of the organization to compare the results from last year and the summary of the results concluded we saw a 90% increase in morale and approximately a 50% increase in the following areas: my immediate supervisor cares about me, my opinions counts, someone talks to me regularly, passionate about where the department is going, buying into the vision, and command staff unity.
- **Police Department** – Officer Mitchell Griffin was asked to provide a K-9 demonstration by a Calvary Church youth group (age of children attending ranged from 5-15 years of age). The goal of the interaction was to create a positive image of law enforcement for the children in attendance. The presentation was well received and Officer Griffin has been invited to be a part of future/ similar events through the church. Officer Griffin is commended for his participation in an activity designed to enhance the department's standing within the community.
- **Human Resources Department** – During March, the department assisted in completing the hiring process for the Police Department, WPCP, and the Parks Department. This process includes pre-employment testing, interviews, background checks, and coordinating pre-employment physicals.
- **Communications Department** - Created and published video tour of new ambulances put into service by Muscatine Fire Department. Assisted with the production and moderated the 2022 State of the City Address with Mayor Brad Bark and City Administrator Carol Webb.

Department of Public Works

The Public Works Department is composed of eight divisions which include: Administration, Building & Grounds Maintenance, Collection & Drainage, Engineering, Roadway Maintenance, Solid Waste, Transit (Muscabus), and Vehicle Maintenance. For budgeting purposes several of these divisions are broken down into subdivisions. For the purpose of the monthly report there will be several divisions that will be reporting consistently, while others may only be reporting on special events or accomplishments.

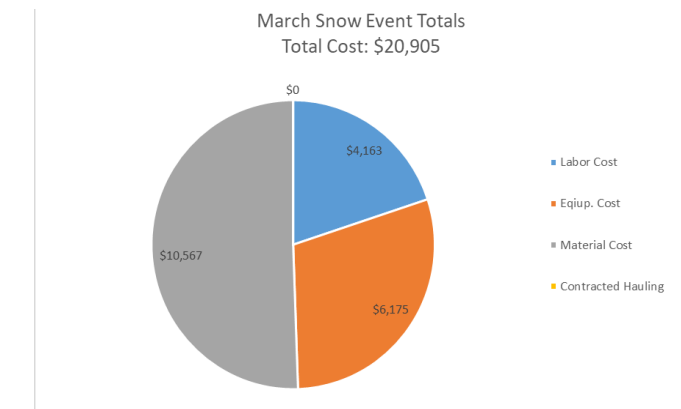
Roadway Maintenance Division Report:

Roadway Maintenance includes activities related to street repairs, snow removal, traffic control, and street cleaning. They are responsible for over 254 lane miles of streets within the city limits.



This measure indicates the number of potholes filled, and the approximate cost to fill each pothole. Beginning January 20, 2021, a "standard" pothole is defined as being the size of large pizza box. Potholes will be divided no smaller than one half of a pizza box.

The chart below shows the amount of time, equipment and material used for snow and ice removal

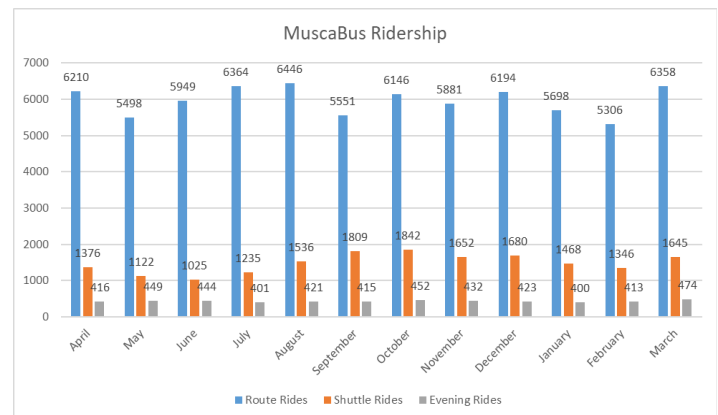


Building and Grounds Activities:

This month in addition to their regular duties including cleaning, plumbing, electrical, HVAC work, supply ordering and delivery, and other regular repairs, staff have been completing multiple projects including: installed a new circulation pump, and restroom vent fan, painted an office and moved furniture in preparation for carpet replacement in City Hall; painted an office, replaced tile flooring, repaired a garage door, completed the lower lot gate project, and moved furniture and offices for preparation for carpet replacement at Public Works; replaced batteries and adjusted the automatic gate at the airport; repaired a backflow valve at the Transfer Station. In addition, staff performed fire extinguisher and furnace preventive maintenance inspections for multiple departments, and cut keys for other departments. At the former Kum & Go Building staff removed bad drywall, installed a furnace and air conditioning unit, replaced all flush valves and replaced plumbing lines and completed roof repairs. Staff continue to utilize the PubWorks asset management software and are now using it to create preventive maintenance work orders, standard operating procedures, and lock out-tag out procedures.

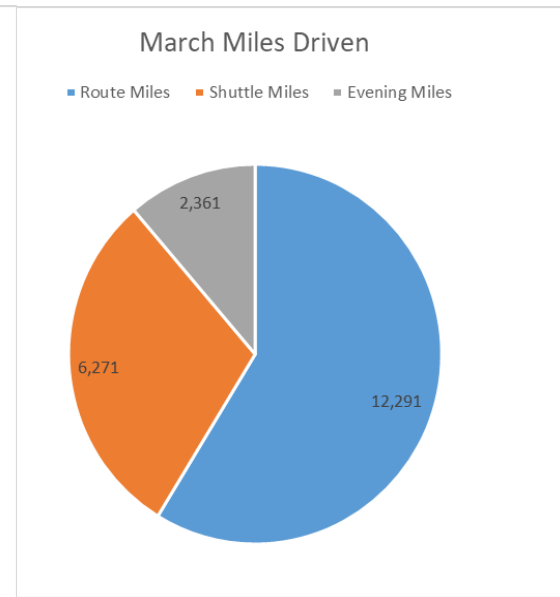
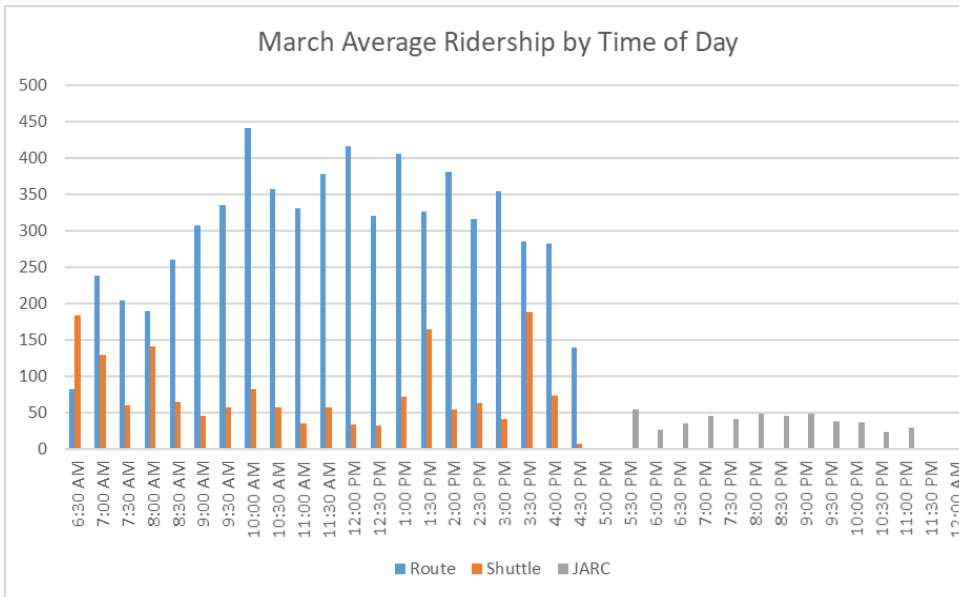
Transit Summary of Operations:

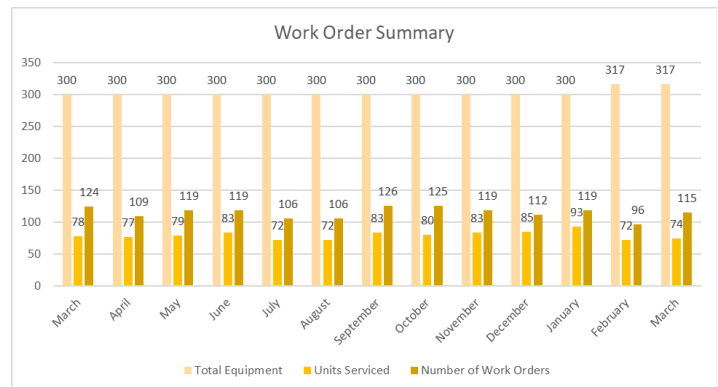

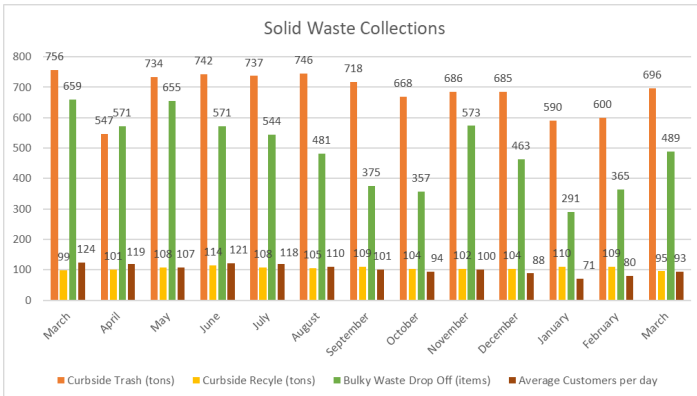
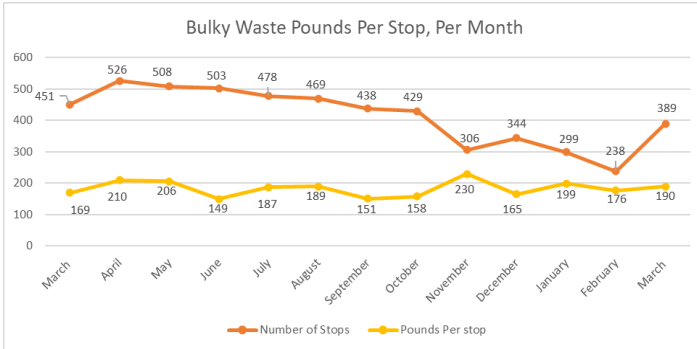

Solid Waste Division Report:

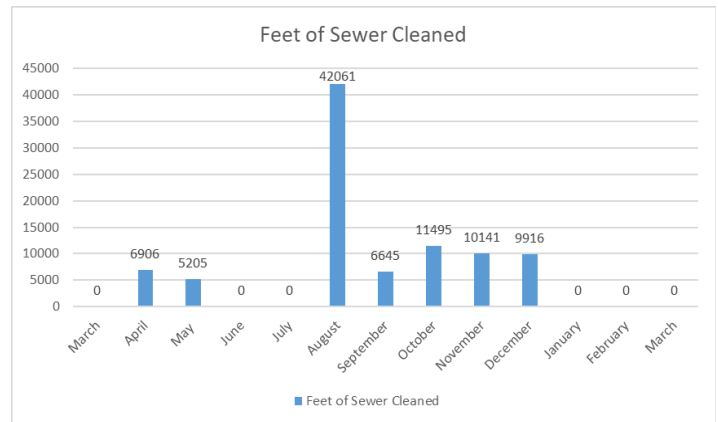
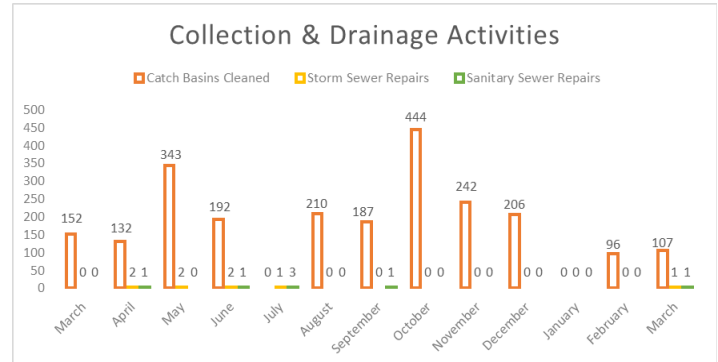
The Solid Waste Division consists of activities related to refuse collection, transfer station, compost site, and landfill, as well as overseeing the contracted recycling collection.

Dropped off items include: electronics, appliances, tires, household hazardous waste and recyclables. Also included is the average number of customers per day at the Transfer Station.

Collection & Drainage Division Report:

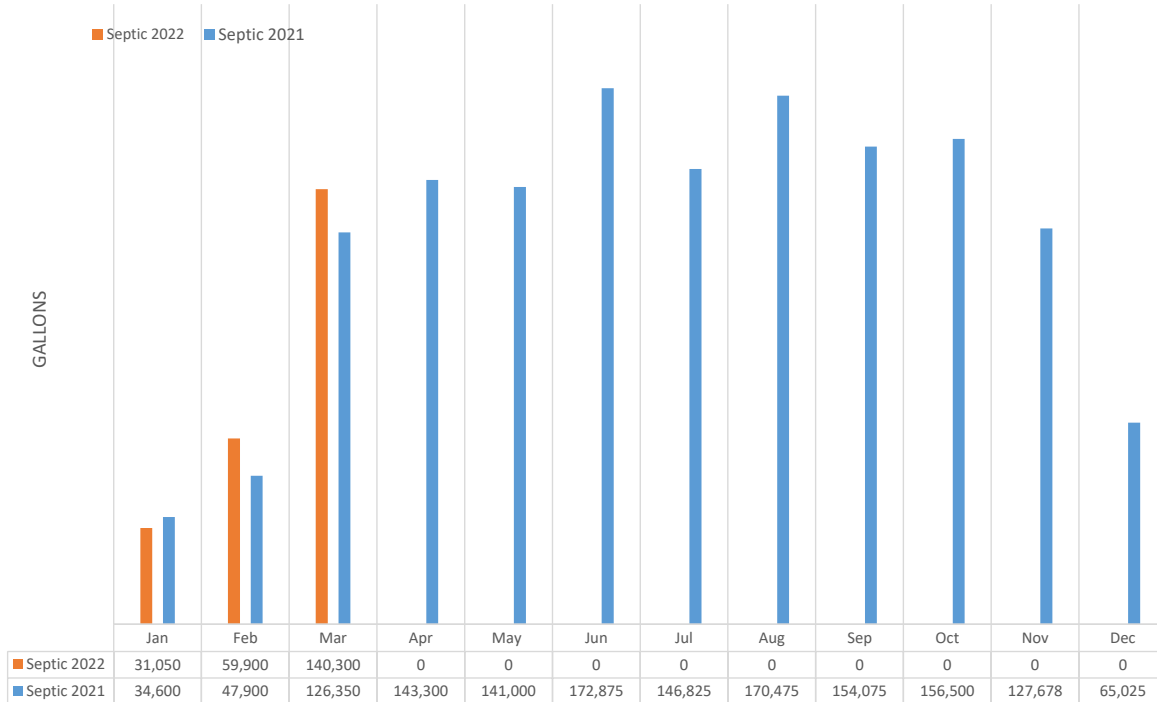
The Collection & Drainage Division is responsible for inspecting and maintaining the city's sanitary, storm, and combined sewer systems. This includes 993 storm water manholes, 2,407 sanitary sewer manholes, 151 combined sewer manholes, 2,840 stormwater catch basins, 112 miles of sanitary sewer and 68 miles of storm sewer pipe.



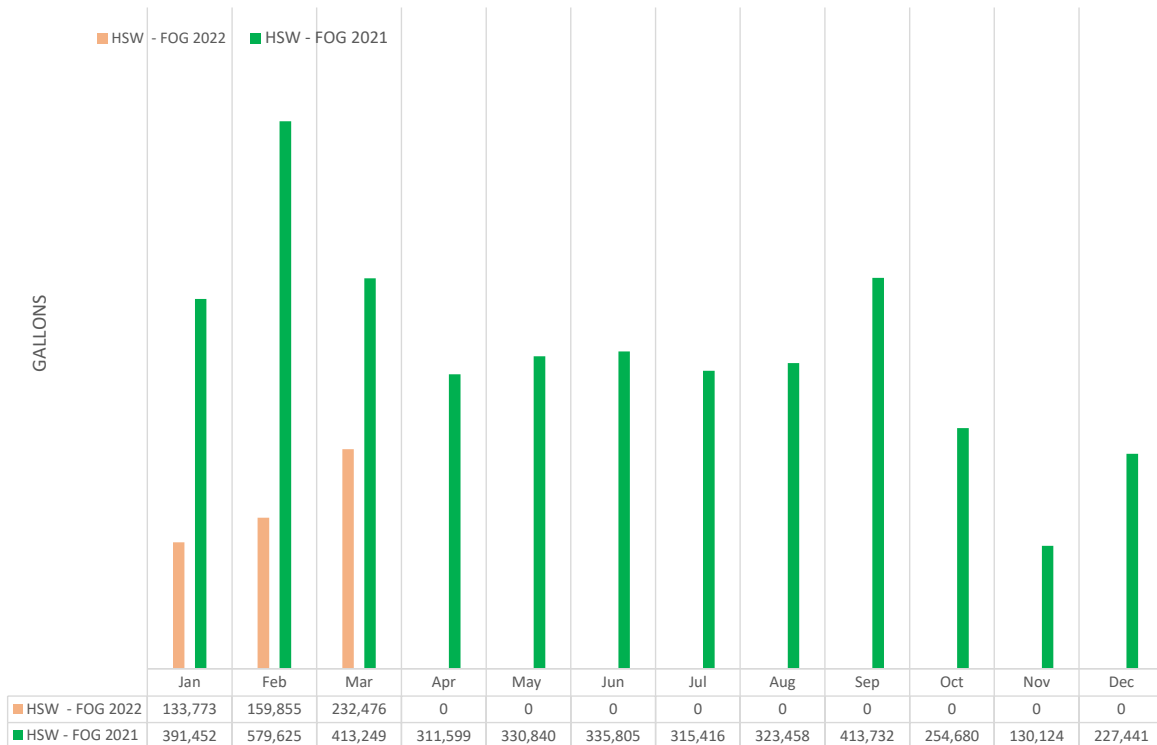

MUSCATINE WRRF HAULED SEPTAGE WASTE 2022

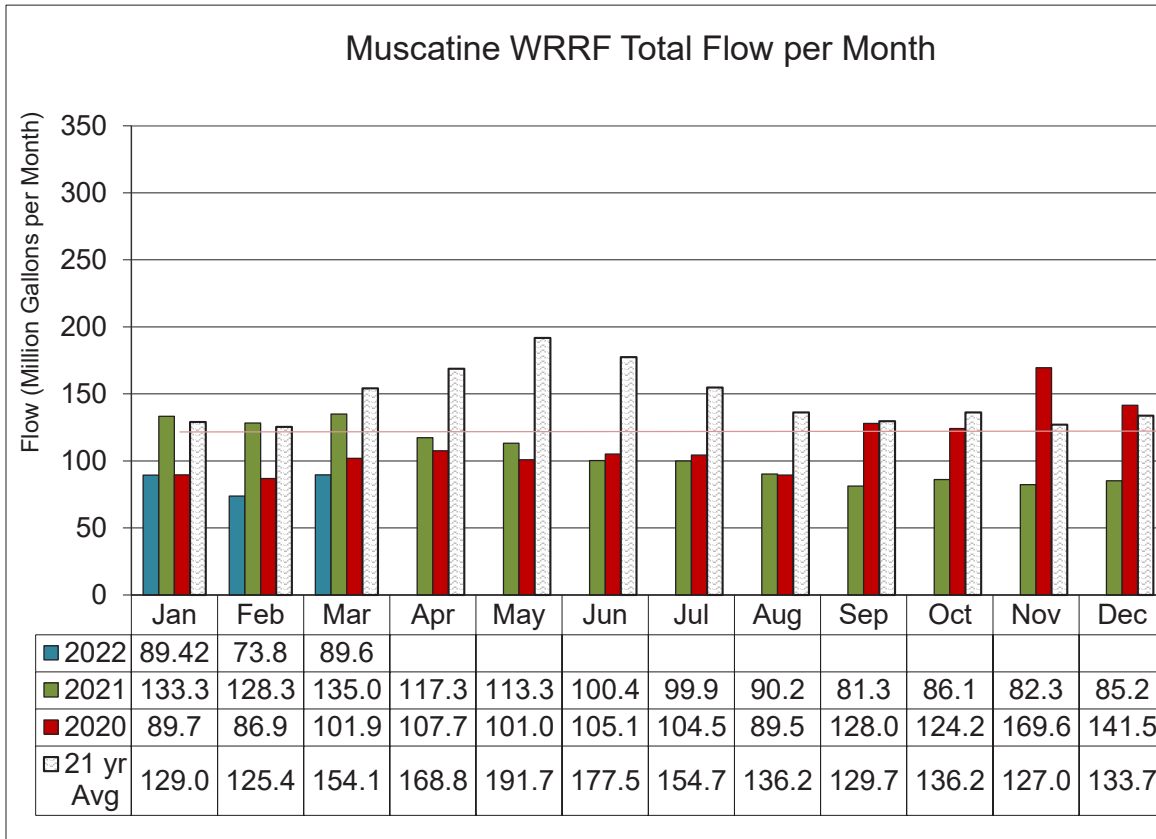
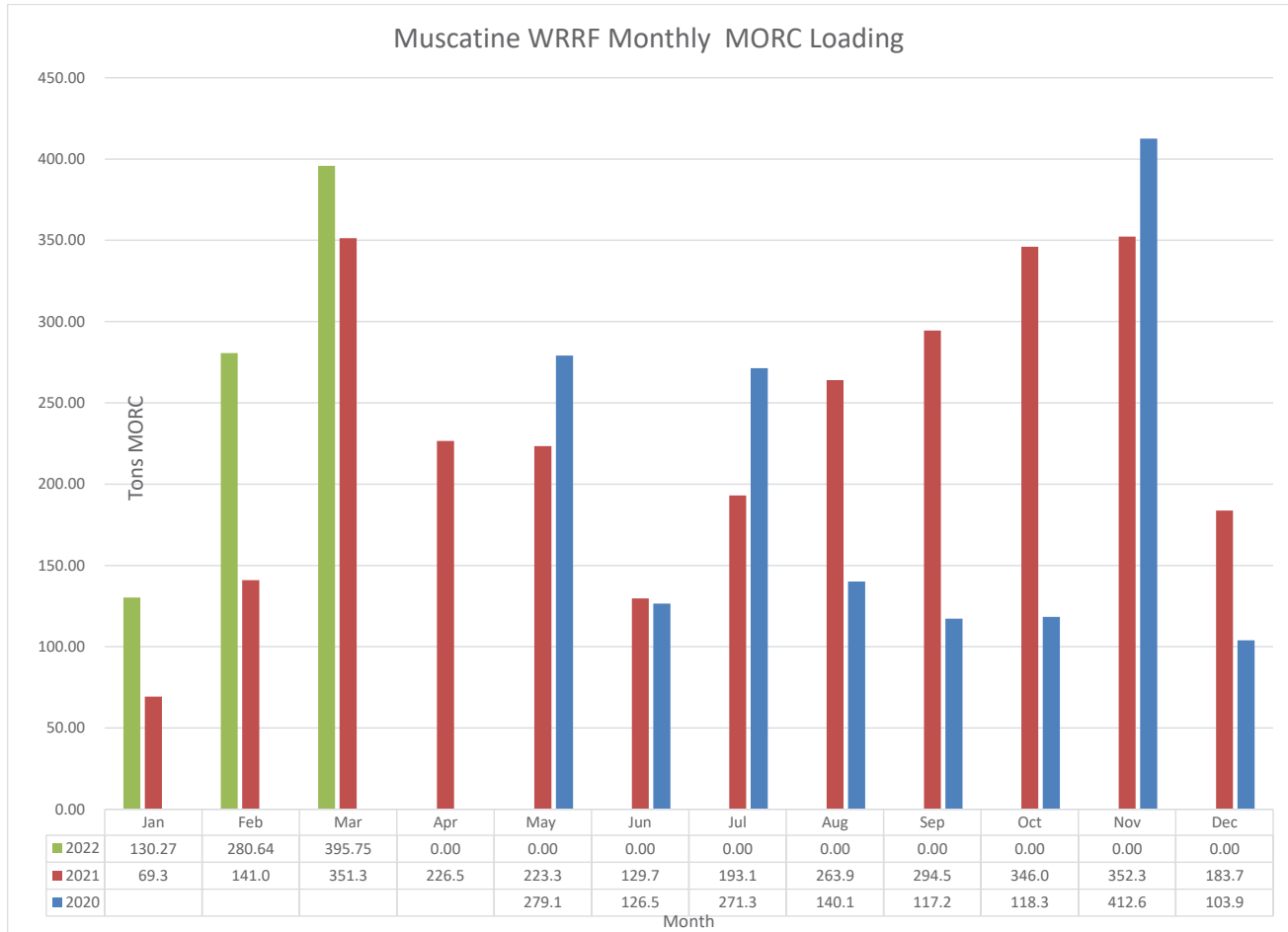


MUSCATINE WRRF HAULED FOG - HIGH STRENGTH WASTE 2022

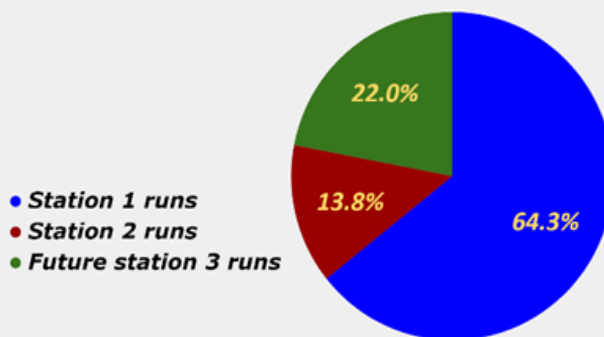
- Acting Fire Lieutenant Brett Becker and Firefighter Craig Chelf participated in Job Fairs across Iowa to help with our recruitment efforts.

- Firefighter Donald Peterson, John Peters, and Yoshio Vo graduated from the recruit academy on March 11th.



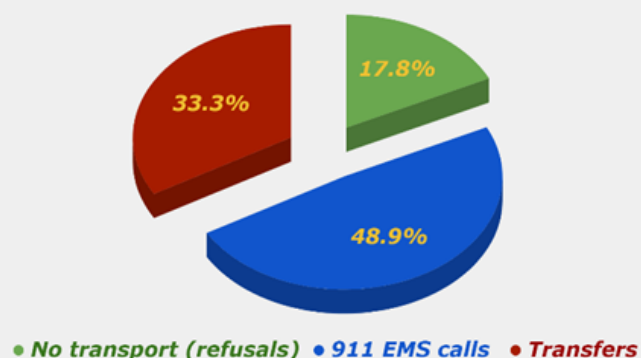

Raisbeck helped Kelly talk to the victims and calm their nerves about testifying at a deposition. Det. Raisbeck later gave the victims a ride to court for the deposition hearing.

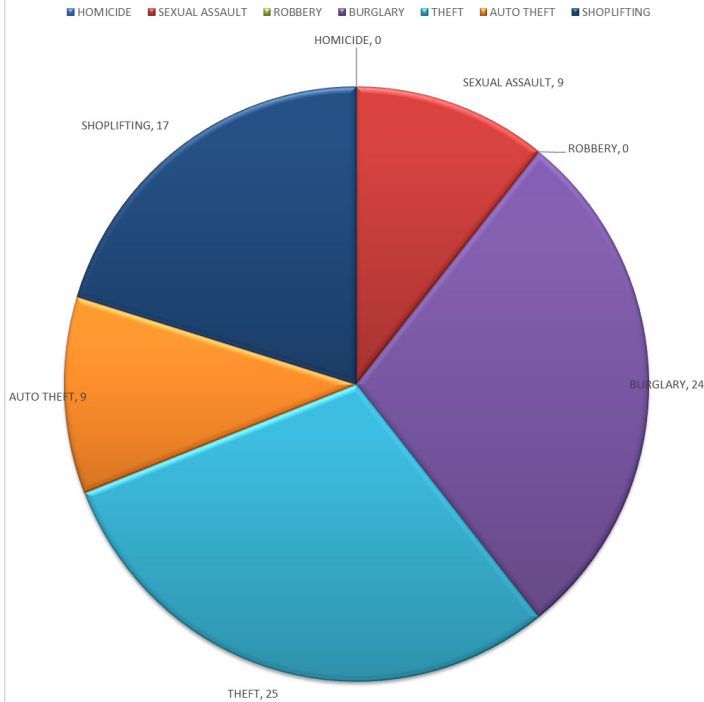

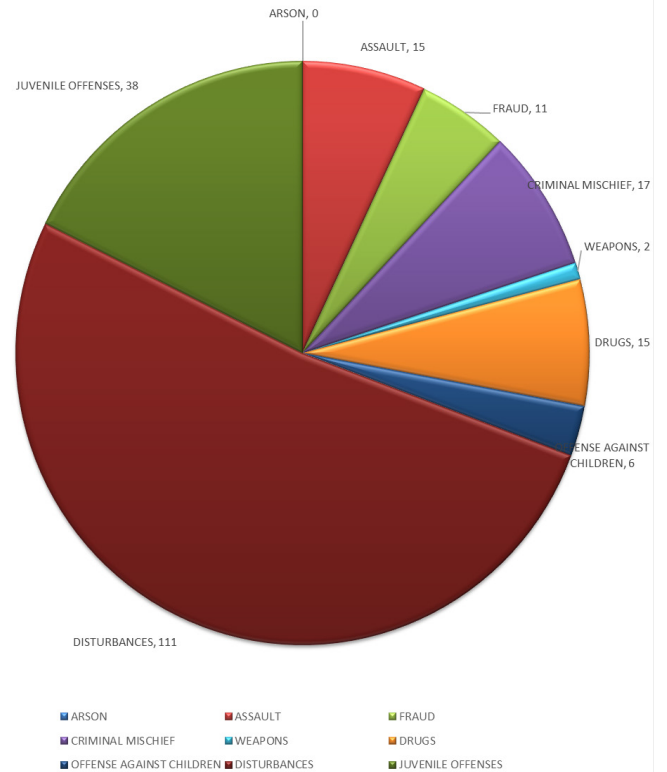

MUSCATINE POLICE DEPARTMENT END OF YEAR STATISTICS

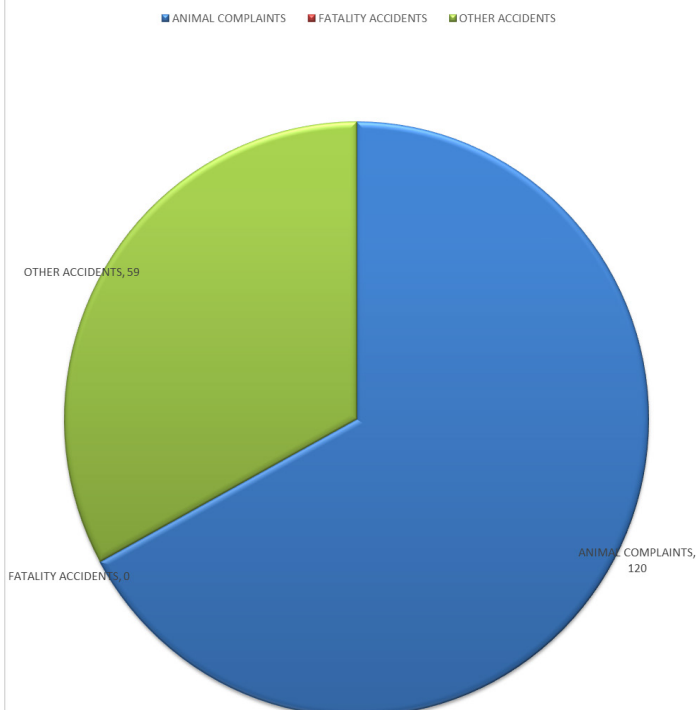
Class I Calls



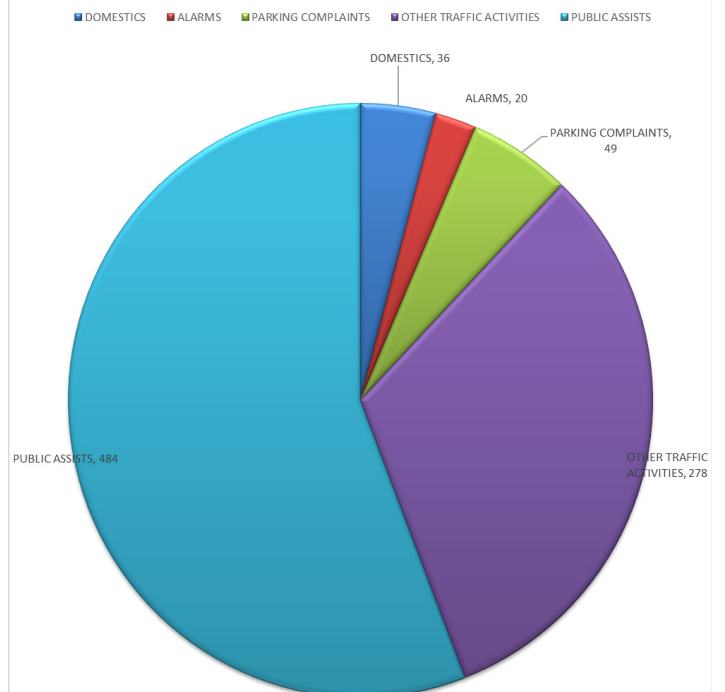
Class II Calls

Park Maintenance Division

The City of Muscatine has been recognized as a Tree City USA community for the 30th consecutive year. In the spring of 2021, the Parks and Recreation Department partnered with HNI Corporation for a donation and planting of 500 trees throughout the community. As a result of this partnership, the City nominated HNI for an Iowa Urban Tree Council award, and in March it was announced that HNI had received the Outstanding Local Partner Award. The City has also applied for a \$5,000 Community Forestry grant through IDNR, with a match from a local business.

Staff has also been busy with cleaning landscape beds throughout the community and preparing them for the spring season. The petunias for the hanging baskets have arrived, and have been transplanted in preparation for the hanging basket program in downtown Muscatine. The boat ramps have installed on the new boat launch on the Riverfront. The tennis courts at Weed Park have been cleaned and the nets have been installed in preparation for the tennis season. Fence repairs were completed in several parks in preparation for the upcoming usage of the parks. The Weed Park and Fuller Park prairies were burnt off to help with weed control and to help new native prairie plants become established.

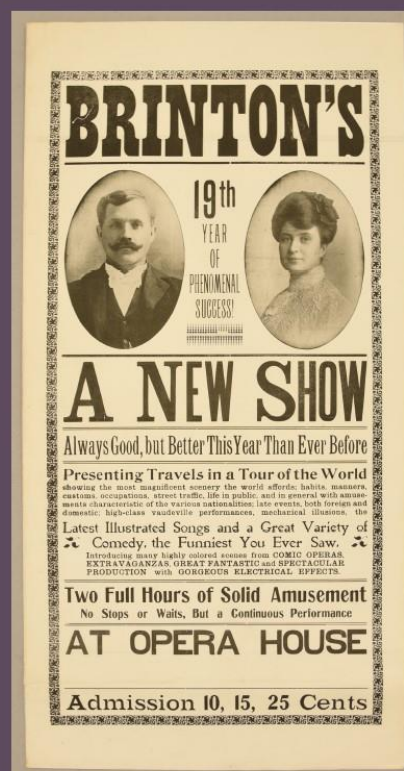
